DESCRIPTION

STABOND U 148A is a brushable, elastomeric contact adhesive which provides high strength bonds to many plastics and synthetic rubbers such as SBR, Neoprene, Nitrile, PVC, ABS and rigid urethane foam.

APPLICATION

STABOND U 148A is formulated for brush application. Surfaces to be bonded must be free of dirt, oil, and grease. Clean the substrate with a solvent such STABOND A Thinner or MEK. Lightly abrading the substrate will improve the bond. Apply a thin uniform film to each substrate and allow 5-10 minutes for the solvent to flash off. Apply sufficient pressure to insure intimate contact. Immediate bond strength permits handling and ultimate adhesion develops within 48 hours.

STORAGE

For maximum shelf life, store material in cool dry area and keep container tightly sealed. Storage temperature of 60°-80°F. is recommended. Lower storage temperature will cause a temporary increase in viscosity. Rotate stock on a "First in First out" basis. For optimum results agitate adhesive prior to use.

WARNING

Extremely flammable. Toxic. Vapors may ignite explosively. Provide fresh air cross ventilation to prevent build-up of vapors. Keep away from heat, sparks and from open flame. Do not smoke. Extinguish all flames and pilot lights and turn off all non-explosion proof electrical equipment and sources of ignition during use and until vapors are dissipated. Avoid breathing of vapors.
